# Mediation


# Do you need help resolving a dispute?

(mediation for leasing issues, disputes between businesses, or business and government)

Speak to us about your issue.



We appoint a mediator to conduct the meeting either in-person or via video call. Both parties contribute to the cost of the mediator.





**Mediation resolves** 

Both parties come to an agreement and the issue is settled.



Mediation doesn't happen or does not resolve the issue


A party can continue to progress through the next steps in the dispute resolution journey.



# **Advocacy**

# Does it involve advocacy?

(representing small businesses in instances of unfair treatment)







Discuss what measures you have already taken to resolve the issue and get advice.

We consider the next steps:

We may contact government bodies or regulators on your behalf.

If the issue affects more businesses, the Commission may advocate for wider change.





### Confidence

27 per cent of businesses indicated they were confident about their individual business prospects.





### **Expansion**

29 per cent of businesses indicated they have plans to grow, alter or expand operations.

### Concerns

82 per cent of businesses indicated they were concerned about the cost of business inputs.





## **Profitability**

16 per cent expect profitability to increase, compared to 37 per cent expecting a decline.





### **Momentum**

The Momentum Index decreased by 1.1 points to 102.9 points.





### Revenue

23 per cent expect revenue to increase, compared to 37 per cent expecting a decline.





### Staff

32 per cent of businesses that have plans to expand are looking to hire additional staff.






### **Local economy**

Given the current operating environment in NSW, to what extent (if any) are each of the following issues a concern for your business?







Chart 1: The first time a company enters external administration or has a controller appointed - NSW, monthly




# Red tape

**Only 1 in 10 businesses** have participated in a

NSW Government public consultation relating to a new policy or regulatory proposal.



**More than half** of businesses said compliance requirements have become harder over the past 12 months. **Just 2 per cent** said it had become easier.



Concerns about **'red tape'** have increased by more than any other issue including business costs, customer demand and cash flow.

Small businesses feel increasingly burdened by the weight of excessive or complex rules and regulations - 'red tape'.
